PURPOSE

The purpose of this policy is to ensure that all students and members of our school community understand:

- (a) our commitment to providing a safe and supportive learning environment for students
- (b) expectations for positive student behaviour
- (c) support available to students and families
- (d) our school's policies and procedures for responding to inappropriate student behaviour.

Tallangatta Secondary College is committed to empowering all to become resilient and confident lifelong learners, with a strong sense of self and community. We understand that students reach their full potential only when they are happy, healthy and safe, and that a positive school culture helps to engage students and support them in their learning. Our school acknowledges that student wellbeing and student learning outcomes are closely linked.

The objective of this policy is to support our school to create and maintain a safe, supportive and inclusive school environment consistent with our school's values.

SCOPE

This policy applies to all school activities, including camps and excursions.

1. School Profile

Tallangatta Secondary College is a small, country, coeducational secondary college located 40 kilometres northeast of Wodonga. The school draws its enrolment from local schools within the Alpine, Indigo, Towong Shire as well as the broader Wodonga district.

Tallangatta Secondary College operates a horizontal curriculum, which offers semester and term length units of study across all Learning areas (Science, Languages, Humanities, Maths, English, Design & Creativity, Health & PE). Curriculum is backward mapped to ensure it is guaranteed and viable. The College also offers a comprehensive Victorian Certificate of Education (VCE) and Vocational Education and Training (VET) curriculum program.

In addition to the curriculum unit offerings, the school offers a broad range of co-curricular programs including; Student Leadership Team, Youth CFA, Tallangatta Herald Newspaper, Instrumental Music and Biennial Northern Territory tour and Overland Trek. The College is proud to offer to our year 9 students the *Future Makers* program in partnership with the Bogong Outdoor School.

Approximately one third of enrolments are Education Maintenance Allowance/Youth Allowance recipients and virtually no students have a language background other than English. – 80% of the school population is bussed in each day from our large catchment area. There are a small number of Koorie students within the school community.

Within the constraints of the architecture, age and location of the buildings, the learning environment is very well-maintained, and the grounds are excellent.

2. School values, philosophy and vision

Our Vision

Tallangatta Secondary College is committed to empowering all to become resilient and confident lifelong learners with a strong sense of self and community.

Our Mission

- To maximise each student's achievement and learning growth by progressing student learning for every student, every day.
- To optimise each student's wellbeing and engagement in learning by empowering student agency.
- To build a culture of continuous improvement where high expectations, collective efficacy and accountability is our agreed moral purpose.

Our Values

Having shared values helps us to set expectations of how we should all behave and treat each other to become a school community that values high performance, strong accountability, positive school culture and continual learning. Living our values shows us at our best and helps us achieve the goals of this strategic plan. At Tallangatta Secondary College, our values are Respect, Empathy, Attitude and Learning (REAL) and are embedded in all our actions and decisions as a school community.

The Way We Learn

We harness learner agency by empowering students to become resilient, resourceful, relating, and reflective learners.

3. Engagement strategies

We are committed to providing a safe, supportive and inclusive environment for all students, staff and members of our community. We build a whole school approach to wellbeing based on collective responsibility through School Wide Positive Behaviour Support (SWPBS), Restorative Practices, Safe Schools and Respectful Relationships

We acknowledge that some students may need extra social, emotional or educational support at school, and that the needs of students will change over time as they grow and learn.

A summary of the universal (whole of school), targeted (year group specific) and individual engagement strategies used by our school is included below:

Universal

- High and consistent expectations of all staff, students and parents and carers.
- Prioritise positive relationships between staff and students, recognising the fundamental role this plays in building and sustaining student wellbeing.
- Creating a culture that is inclusive, engaging and supportive.
- Welcoming all parents/carers and being responsive to them as partners in learning.
- Analysing and being responsive to a range of school data such as attendance, Attitudes to School Survey, parent survey data, student management data and school level assessment data.

- Deliver a broad curriculum including Victorian Certificate of Education (VCE) and Vocational Education and Training (VET) curriculum programs to ensure that students are able to choose subjects and programs that are tailored to their interests, strengths and aspirations.
- Teachers at Tallangatta Secondary College use instructional model (Effective Teaching Techniques) to ensure an explicit, common and shared model of instruction to ensure that evidenced-based, high yield teaching practices are incorporated into all lessons.
- Teachers at Tallangatta Secondary College adopt a broad range of teaching and assessment approaches to effectively respond to the diverse learning styles, strengths and needs of our students and follow the standards set by the Victorian Institute of Teaching.
- Our school's Statement of Values are incorporated into our curriculum and promoted to students, staff and parents so that they are shared and celebrated as the foundation of our school community.
- Carefully planned transition programs to support students moving into different stages of their schooling.
- Positive behaviour and student achievement is acknowledged in the classroom, and formally in school assemblies and communication to parents.
- Monitor student attendance and implement attendance improvement strategies at a whole school, cohort and individual level.
- Students have the opportunity to contribute to and provide feedback on decisions about school operations through the Student Leadership Team and other forums. Students are also encouraged to speak with their Learning Mentor, teachers, Engagement Leaders, Assistant Principal and Principal whenever they have any questions or concerns.
- Create opportunities for cross—age connections amongst students through college productions, athletics, swimming, cross country sports programs, music programs, peer support programs and REAL homegroups.
- All students are welcome to self-refer to the School Nurse, Chaplain, Mental Health Practitioner, Engagement Leaders, REAL mentor, Assistant Principal and Principal if they would like to discuss a particular issue or feel as though they may need support of any kind.
- We are proud to have an 'open door' policy where students and staff are partners in learning.
- We engage in school wide positive behaviour support with our staff and students, which includes programs such as Respectful Relationships, Safe Schools, Restorative Practices and School Wide Positive Behaviours Support.

Targeted

- Each Engagement Leader monitors the health and wellbeing of students, and act as a point of contact for students who may need additional support.
- All students will be assisted to develop a Career Action Plan, with targeted goals and support to plan for their future.
- Connect all Koorie students with a Koorie Engagement Support Officer.
- all students in Out of Home Care will be appointed a Learning Mentor, have an Individual Education Plan and will be referred to Student Support Services for an Educational Needs Assessment.
- Tallangatta Secondary College assists students to plan their Year 10 work experience, supported by their Career Action Plan and Year 9 Morrisby testing.

- Wellbeing staff will undertake health promotion and social skills development in response to needs identified by student wellbeing data, classroom teachers or other school staff each year.
- Staff will apply a trauma-informed approach to working with students who have experienced trauma.

Tallangatta Secondary College implements a range of strategies that support and promote individual engagement. These can include:

- Building constructive relationships with students at risk or students who are vulnerable due to complex individual circumstances.
- Meeting with student and their parent/carer to talk about how best to help the student engage with school.
- Developing an Individual Education Plan and/or a Behaviour Support Plan.
- Considering if any environmental changes need to be made, for example changing the classroom set up.
- Referring the student to:
 - school-based wellbeing supports
 - Student Support Services
 - Appropriate external supports such as council-based youth and family services, other allied health professionals, headspace, child, and adolescent mental health services or Child First.
 - Re-engagement programs e.g. Navigator

Where necessary the school will support the student's family to engage by:

- Being responsive and sensitive to changes in the student's circumstances and health and wellbeing.
- Collaborating, where appropriate and with the support of the student and their family, with any external allied health professionals, services or agencies that are supporting the student.
- Monitoring individual student attendance and developing an Attendance Improvement Plans in collaboration with the student and their family.
- Running regular Student Support Group meetings for all students with a disability, in Out of Home Care and with other complex needs that require ongoing support and monitoring.

4. Identifying students in need of support

Tallangatta Secondary College is committed to providing the necessary support to ensure our students are supported intellectually, emotionally, and socially. The Student Wellbeing team plays a significant role in developing and implementing strategies help identify students in need of support and enhance student wellbeing. Tallangatta Secondary College will utilise the following information and tools to identify students in need of extra emotional, social, or educational support:

- Personal, health and learning information gathered upon enrolment and while the student is enrolled.
- Attendance records
- Learner dispositions
- Observations by school staff such as changes in engagement, behaviour, self-care, social connectedness, and motivation.
- Attendance, detention, and suspension data.
- Engagement with families
- Self-referrals or referrals from peers.

5. Student rights and responsibilities

All members of our school community have a right to experience a safe and supportive school environment. We expect that all students, staff, parents and carers treat each other with respect and dignity. Our school's Statement of Values highlights the rights and responsibilities of members of our community.

Students have the right to:

- Participate fully in their education.
- Feel safe, secure and happy at school.
- Learn in an environment free from bullying, harassment, violence, discrimination or intimidation.
- Express their ideas, feelings and concerns respectfully.

Students have the responsibility to:

- Participate fully in their educational program.
- Display positive behaviours that demonstrate respect for themselves, their peers, their teachers and members of the school community.
- Respect the right of others to learn.

Students who may have a complaint or concern about something that has happened at school are encouraged to speak to their parents or carers and approach a trusted teacher or a member of the school leadership team.

6. Student behavioural expectations and management

Behavioural expectations of students, staff and families are grounded in our school's Statement of Values. Student bullying behaviour will be responded to consistently with Tallangatta Secondary College's Bullying Prevention policy.

When a student acts in breach of the behaviour standards of our school community, Tallangatta Secondary College will institute a staged response, consistent with the Department's Student Engagement and Inclusion Guidelines. Where appropriate, parents will be informed about the inappropriate behaviour and the disciplinary action taken by teachers and other school staff.

Disciplinary measures may be used as part of a staged response to inappropriate behaviour in combination with other engagement and support strategies to ensure that factors that may have contributed to the student's behaviour are identified and addressed. Disciplinary measures at our school will be applied fairly and consistently. Students will always be provided with an opportunity to be heard.

Disciplinary measures that may be applied include:

- Warning a student that their behaviour is inappropriate.
- Teacher controlled consequences such as moving a student in a classroom or other reasonable and proportionate responses to misbehaviour.
- Withdrawal of privileges
- Referral to the Student Engagement Leader
- Restorative practices
- Detentions
- Behaviour reviews
- Suspension
- Expulsion

Suspension and expulsion and restrictive intervention are measures of last resort and may only be used in particular situations consistent with Department policy, available at:

In line with Ministerial Order 1125, no student aged 8 or younger will be expelled without the approval of the Secretary of the Department of Education and Training.

The Principal of Tallangatta Secondary College is responsible for ensuring all suspensions and expulsions are recorded on CASES21.

Corporal punishment is prohibited by law and will not be used in any circumstance.

7. Engaging with families

Tallangatta Secondary College values the input of parents and carers, and we will strive to support families to engage in their child's learning and build their capacity as active learners. We aim to be partners in learning with parents and carers in our school community.

We work hard to create successful partnerships with parents and carers by:

- Ensuring that all parents have access to our school policies and procedures, available on our school website.
- Involving families with homework and other curriculum-related activities.
- Involving families in school decision making.
- Coordinating resources and services from the community for families.
- Including families in Student Support Groups and developing individual plans for students.

8. Evaluation

Tallangatta Secondary College will collect data each year to understand the frequency and types of wellbeing issues that are experienced by our students so that we can measure the success or otherwise of our school-based strategies and identify emerging trends or needs.

Sources of data that will be assessed on an annual basis include:

- Student survey data
- Compass data
- Parent survey data
- Attendance and absence data
- Staff survey data.

Tallangatta Secondary College will also regularly monitor available data dashboards to ensure any wellbeing or engagement issues are acted upon in a timely manner and any intervention occurs as soon as possible.

COMMUNICATION
